**RESTRAINTS:**

DO NOT leave baits accessible to domestic animals, livestock, and wildlife including birds.  
DO NOT apply directly to crops.  
DO NOT allow bait to contaminate foodstuff or feed intended for human or animal consumption. Containers which have held bait should not be used for any other purpose.

**Situation**

Domestic & commercial premises  
around grain storages, farm buildings & animal housing

**Rate of application**

50-500g per bait station

Place bait stations less than 3m apart, in areas inaccessible to animals & birds. If possible apply bait in the late afternoon. Eliminate, as far as possible, all alternative feed sources for the rats or mice. Bait required will depend on mouse or rat numbers. Continue to replenish bait eaten daily until no more bait is taken.

**STORAGE AND DISPOSAL:**

Storage of product: Store in a safe place.  
Disposal of bait: Bait that is not eaten by the end of the baiting program is to be collected and destroyed by incineration, or buried to a depth of 50 cm.  
Disposal of containers: Break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 50 cm in a disposal pit.  
Empty containers should not be burnt.

**SAFETY DIRECTIONS:** Poisonous if swallowed. Do not inhale dust. Repeated minor exposure may have a cumulative poisoning effect. Avoid contact with eyes and skin. Do not touch bait. Use scoop or measure. If on skin and after each baiting, wash thoroughly with soap and water. Vitamin K1 (phytomenadione) is antidotal.
