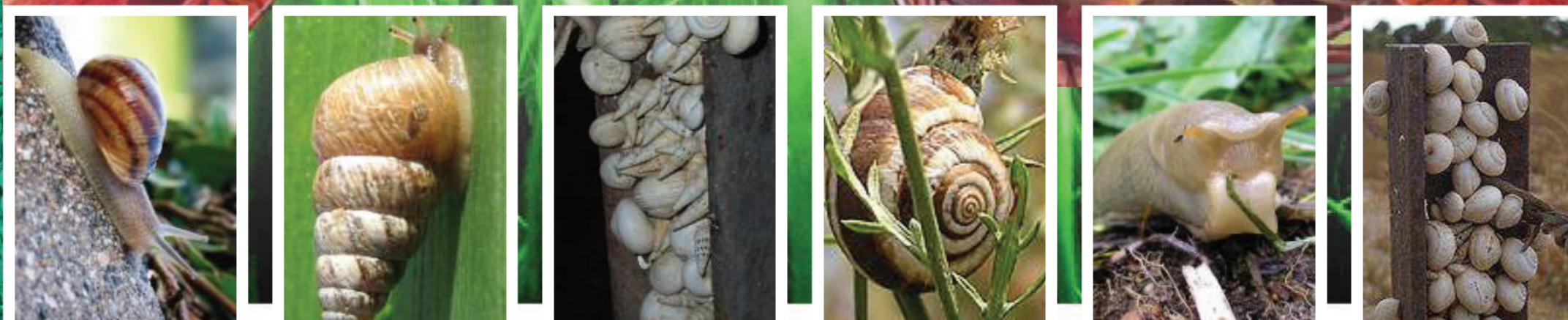

Best results are achieved by application after rain, watering or during damp and humid weather when the snails and slugs are most actively seeking food but not when rain is imminent. Scatter baits evenly using an appropriate applicator by ground or air, or direct drill with seed for slug control. Clean up spilled baits after filling applicator or whenever the baits are spilt.

PRECAUTIONS:

DO NOT use human flaggers/markers unless they are protected by engineering controls such as enclosed cabs.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA AND ENVIRONMENT:

DO NOT contaminate streams, rivers or waterways with the product or used containers.

PROTECTION OF DOMESTIC ANIMALS AND LIVESTOCK:

Keep away from animals, poultry, ducks and domestic pets as accidental poisoning may be fatal. DO NOT graze or cut for stock feed any area while Delicia® SLUGGOFF® Lentils are visible in the plant foliage. If pets or livestock are poisoned, contact a veterinary surgeon.

STORAGE AND DISPOSAL:

Store in the closed original container in a dry, cool, well ventilated area out of direct sunlight. Store in a locked room or place away from children, animals, food, feedstuff and fertilisers. Before disposal ensure container is completely empty by shaking. Break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

SAFETY DIRECTIONS:

When opening the container and loading and if applying by hand, wear cotton overalls buttoned to the neck and wrist (or equivalent clothing) and elbow-length rubber gloves. After each day's use, wash gloves and contaminated clothing. Wash hands after use.

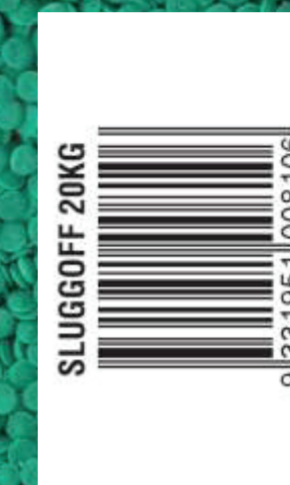

RESTRAINTS

DO NOT apply to crops once windowed. DO NOT apply to edible plant parts or to crops where bait may be collected with harvested commodity. DO NOT place baits in heaps.

Delicia® SLUGGOFF® is to be used only during the establishment stages of pastures. Broadcast pellets evenly over the crop area to be protected either prior to planting, post-plant pre-emergence or early post-emergence (prior to 4 leaf stage). Use higher rate where there are large populations of snails or slugs and where wet and cool climatic conditions favour snail and slug movement.

This product contains denatonium benzoate bitter flavour as a child and pet taste deterrent. **NOT TO BE USED FOR ANY PURPOSE OR IN ANY MANNER CONTRARY TO THIS LABEL UNLESS AUTHORISED UNDER APPROPRIATE LEGISLATION.**

WITHHOLDING PERIOD:

HARVEST:
HORTICULTURAL CROPS, VINEYARDS: DO NOT apply later than 7 days (1 week) before harvest.

AGRICULTURAL CROPS: DO NOT apply later than 8 weeks before harvest.

GRAZING:
PASTURES, PULSES, OILSEEDS (INCLUDING POPPIES) WINTER CEREALS: DO NOT graze or cut for stock food for 5 week after application. ALL OTHER CROPS: DO NOT allow stock or poultry to graze treated crops

GENERAL INSTRUCTIONS:

Delicia® SLUGGOFF® Lentils have a stomach and contact action in slugs and snails that induces heavy secretion of mucous with the consequence that slugs and snails die in a reasonably short time from dehydration. Delicia® SLUGGOFF® Lentils are particularly active against molluscs. If the product is applied according to the directions of use, non-target organisms will not be affected. Addition of a bittering agent has made Delicia® SLUGGOFF® Lentils distasteful to mammals and birds.
